Some 2013 Escape vehicles equipped with 1.6L Gasoline Turbocharged Direct Injection (GTDI) engine built on or before 12/13/2012 and 2.0L GTDI engines built on or before 12/23/2012 may exhibit a harsh 5-3 or 5-4 downshift condition during coast down events, before the powertrain reaches normal operating temperature.

ACTION

Reprogram the powertrain control module (PCM) to the latest calibration using Integrated Diagnostic System (IDS) release 83.01 and higher. Calibration files may also be obtained at www.motorcraft.com.
